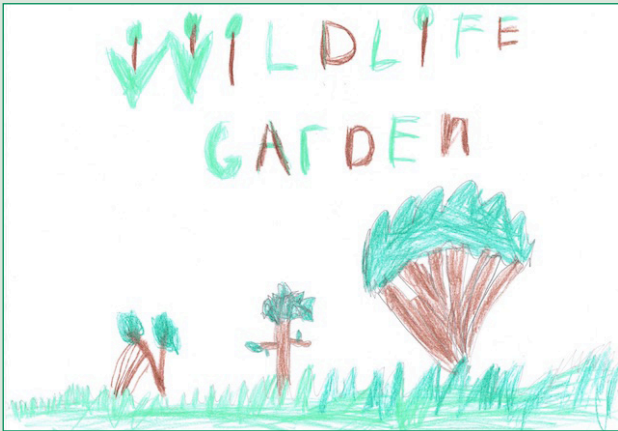

WORKING TOGETHER

The preparation of this Community Action Plan has been organised by a Steering Group which brought together representatives from Kinross Community Council, Kinross-shire Partnership, KLEO, Kinross Centre, CHAS, Broke Not Broken, KYTHE, Kinross-shire Civic Trust, Greener Kinross-shire, and interested local residents and volunteers.



LOCAL PEOPLE HAVE THEIR SAY

The Action Plan has been informed by extensive community engagement carried out over a six-month period from April to September 2025.

The process involved:

- a **Community Views Survey** delivered to households across the area, available in public locations, and online
- a series of **Stakeholder Conversations** with community organisations, and local people representing a wide range of interests from across the area
- a **Business Survey** distributed widely and available online
- compiling a **Community Profile** of facts and figures about the area
- organising a **Community Open Day Event** so people could see the results of the survey, stakeholder conversations and profile and then vote for their priorities.

LOCATION

Kinross is a historic county market town on the western side of Loch Leven located around 13 miles south of Perth and 20 miles north-west of Edinburgh. It is a hub for the surrounding villages – in Kinross-shire and Fife – offering a wide range of businesses, services, facilities and amenities.

Kinross is at the heart of transport links between the south and north of Scotland. The M90 – the main motorway between Edinburgh and Perth – passes just to the western edge of the town. The M90 connects to the A9 north and the A90 up the east coast to Dundee and Aberdeen.

The Kinross Community Council area, in addition to Kinross itself, embraces Castle Island, some of Loch Leven, and some hinterland to the west and south – including Balado and Gairneybank.

POPULATION AND HOUSING

The population of Kinross was 5,609 (at the time of the 2022 Census) an increase of 14.7% since 2011, which was much greater than the 2.9% growth for Perth and Kinross. Most notable changes in the composition of the Kinross population between the two censuses were:

- A significant decline in the percentage of those in the working age range - down from 62% to 56%.
- A large rise in the percentage of the population in the over 65's age group - up from 19% to 26%.

The total number of occupied houses in the Kinross settlement rose from 2,120 in the 2011 Census to 2,606 in the 2022 Census. This is a significant growth of 23% since 2011 and much greater than the 8% growth in occupied houses in Perth and Kinross. There has been further increase in housing development since the 2022 Census, with planning consent for at least another 350 homes over the next few years.

EMPLOYMENT AND THE LOCAL ECONOMY

The main economic sectors offering employment for residents in Kinross are in Health and Social Work, Wholesale and Retail, Education, Public Administration, Construction and Manufacturing, and Accommodation and Food Services.

Large employers locally include CHAS, the Schools, and the Health Centre. The local manufacturing sector includes Todd and Duncan (cashmere spinning since 1897) which still has a prominent role in the community.

Although still significant, there has been a decrease in the number of people employed in both retail and hospitality when comparing the 2022 figures with those of the previous census in 2011. Together they accounted for 23% of employment in 2011 and dropped to 19% by 2022.

Visitors to Loch Leven have increased over the years with the success of the Heritage Trail as well as visitors to the Castle and the RSPB site – with visitor numbers now around 350,000 a year – so there is a strong link to be nurtured between the local economy and the wellbeing of the loch.

The Kinross-shire Partnership and KLEO (Kinross-shire Local Events Organisation) both play an important role in developing the local economy, supporting the networking of businesses, and organising regular Market Days and events.

EDUCATION

Kinross Primary School is one of the largest primary schools in Perth and Kinross with 18 'mainstream' classes and a roll of around 450 pupils. The School Nursery is registered for a maximum of 85 children at any one time.

Kinross High School is set within the Loch Leven Community Campus with a current roll of around 900 pupils. Feeder Primary Schools are Kinross, Cleish, Arngask, Portmoak, Fossoway and Milnathort.

Perth College UHI closed the Learning Centre in Kinross (along with others in Crieff and Blairgowrie) in 2019. The nearest FE Colleges are in Perth and Dunfermline.

HEALTH, CARE AND EMERGENCY SERVICE

Facilities and services include:

- Loch Leven Health Centre – GPs, District Nurses and a range of clinical support
- Main hospitals in Ninewells, Dundee and Perth Royal Infirmary, Perth
- Pharmacies in Kinross and Milnathort
- Private dentist in Kinross but no NHS service
- Ambulance - Kinross is served by the Tayside and Fife sub-divisions of the Scottish Ambulance Service
- Kinross First Responders – trained local volunteers who can provide assistance before an ambulance arrives
- Public access Defibrillators throughout the town
- Police Station in Kinross High Street – no longer has a public counter service but serves as a base for community officers
- Kinross Fire Station – operates with a retained crew on call 24 hours



Many local charities and organisations provide vital caring and support services across the community including:

- Kinross-shire Centre – day care services for the elderly
- Broke Not Broken – anti poverty charity
- Kinross-shire Volunteer Drivers
- Kinross Men's Shed and She Shed
- Kinross Trishaws and Community Cycling

Elderly care homes and housing include:

- Ashley House Residential Care Home (Milnathort),
- Balhousie Residential Care Home (Rumbling Bridge)
- Sheltered housing and retirement housing at Whyte Court (Hanover Housing), Causeway Court (PKC), The Sycamores (McCarthy Stone), and Sir Alan Smith Gardens retirement living.

COMMUNITY GROUPS, FACILITIES AND EVENTS

OUTDOOR RECREATION AND OPEN SPACES

Provision includes:

- Playing Fields - King George V, Myre Park, Davies Park, Loch Leven Campus, Kinross Primary School, Donaldson Park (Milnathort)
- Play areas at Davies Park, Green Park, Kirkgate Park, Myre Park, Lathro Park and Levenfields
- Montgomery and Bruce 18 hole golf courses
- Kinross Tennis Club
- Kinross Bowling Club
- Public Parks and Gardens include: Myre Park, Kirkgate Park, Gace Gardens, Green Park, Hayfield Garden and Davies Park

ENVIRONMENT AND HERITAGE

Paths and Access

There are 15 designated core paths in and around Kinross. The Loch Leven Heritage trail is a circular path of 21km around the loch, suitable for all abilities access. Kinross is on the route of two main National Cycle Networks – NCN1 and NCN 775. The current NCN route 776 runs through the centre of Kinross.



Loch Leven Nature Reserve

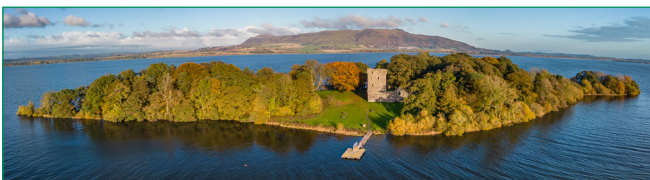
Loch Leven is an internationally important site for water birds, with huge flocks of wintering wildfowl gathering each autumn. In October, around 10% of the world's population of pink-footed geese arrive at the loch. The National Nature Reserve site is managed by NatureScot with staff based at its offices at The Pier.

Lochleven Castle

The island castle on Loch Leven is renowned for the imprisonment of Mary, Queen of Scots in 1567. It is also where she abdicated the Scottish throne in favour of her infant son James VI (later to become King James I of England). The site is managed by Historic Environment Scotland and includes the provision of a seasonal boat service for visitors.



Local environment and heritage groups and initiatives

Kinross-shire Civic Trust has championed the development of Rain Gardens with over 20 projects completed. CATCH (Climate Action Through Community Heating) is a local group that aims to reduce the carbon footprint in Kinross and Milnathort by introducing a district heating network using renewable energy sources. Greener Kinross-shire, Kinross Climate Café and Repair Café are working to tackle the effects of climate change through recycling and reuse initiatives. Kinross (Marshall) Museum is an independent charitable trust dedicated to the history and heritage of Kinross-shire. It is currently located within the Loch Leven Community Campus.

Some other heritage connections

Kinross's past also includes its role as:

- a staging post on the Great Northern Road and then at the crossroads of three railway lines
- a centre for the manufacture of cutlery from the late 17th to the early 20th Century
- a centre for weaving during the 18th and 19th Centuries which includes its role as a world leader in cashmere spinning
- home to the oldest Curling Club in Scotland (and possibly the world) dating back to 1668
- home to the first CHAS hospice in Scotland



Kinross Conservation Area

A conservation area was first designated in Kinross in 1977 and extended in 1989. It recognises and ensures that the centre of Kinross retains strong architectural and historic character which demonstrates its evolution and creates a unique, high-quality environment. This character is seen as being important for the quality of life and economic health of the town, in the present and the future.

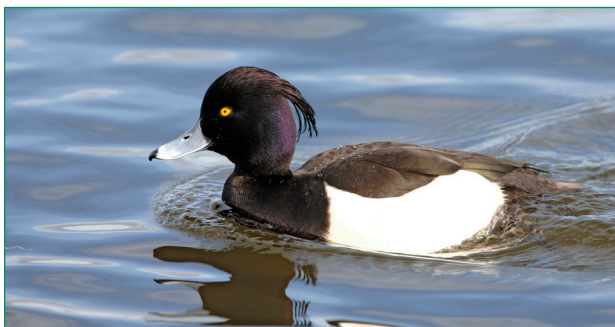
This statement has been prepared using local residents' and organisations' answers to the question –

MAIN STRATEGIES AND PRIORITIES

'What we need to do over the next 5 years to make the area better to live in, work in and visit.'

These are the main strategies and priorities that have emerged from the results of the community engagement work – the community views survey, the stakeholder conversations and the community event. They are a guide to what the community and its organisations will focus on and try to make happen over the next 5 years.

THEME 1: FUTURE DEVELOPMENT AND SUSTAINABILITY

Most of the priorities in this CAP reflect a desire to shape the future in light of the fast growth in housing and population over the last 20 years and the need to be proactive in creating a more balanced and sustainable community, economy and environment in the future.

There was a strong desire:

- to encourage a phase of consolidation in Kinross rather than expansion of its population and housing – and for this to be reflected in the new Local Development Plan
- To ensure that there were sites identified for employment and business development and that these sites were not used for further housing (in general and with specific reference to the BCA site)
- to reduce impacts of climate change – in particular reducing flooding risk and continuing to improve water quality in Loch Leven
- To make the most of opportunities for local renewable energy initiatives and energy use reduction
- To see continuing development of active travel and public/community transport

Main Priorities

- The new Local Development Plan – consolidation not expansion
- More sites for new/expanding businesses (including BCA site)
- Reduce impacts of climate change
- Renewable and reduced energy use
- Active and sustainable transport



THEME 2: LOCAL ECONOMY AND TOWN CENTRE

It was thought to be important to prioritise sites for employment and local businesses in Kinross rather than for housing. A current focus for this concern was the old British Car Auction site, with a desire to see it developed – as originally proposed – as a site for businesses, and not for housing. The need to develop more retail provision was emphasised with preference for a new supermarket and petrol station.

It was felt that more could be done to increase the attraction of the town centre – making it more animated and more accessible to locals and visitors. There is an opportunity to build on the work of KLEO and the Kinross-shire Partnership in supporting the local economy and local businesses. Improvements to accessibility include a need for better and safer active travel routes for walking and cycling, and for improvements to parking.

In general it was thought that more could be done to attract visitors to Kinross, and specifically to develop the links with Loch Leven - through improvements to road and path access as well as more provision of visitor information about the town at Loch Leven e.g. through a local visitor centre.

Main priorities

- Employment/business sites and premises
- A more accessible town centre
- More for visitors
- Connections with Loch Leven
- Business services, support and networking



THEME 3: ENVIRONMENT AND HERITAGE

It was widely recognised that Loch Leven is the jewel in the Kinross crown – and that its health and management is important to Kinross's future. To this end, the community realise they have a vested interest In working with the NatureScot National Nature Reserve, RSPB, Historic Environment Scotland, Forth Rivers Trust and local land managers. Local groups, including Greener Kinross-shire, Kinross-shire Civic Trust (Rain Gardens), TRACKS and CATCH, all have a major role to play and their work should be supported.

There has been concern about the need to retain and enhance local greenspaces in Kinross in the face of pressure for housing development. It was seen as important to maintain this focus and to support the work of local organisations e.g. KOSAG, Kinross-shire Civic Trust, Kinross Community Council, Kinross in Bloom, Potager Garden, and Greener Kinross-shire.



Continuing to maintain and develop local paths networks that support and provide access to countryside, open spaces and outdoor recreation is highly valued and the work of TRACKS and Kinross Trishaws and Community Cycling should be supported over the next years. This should include improving links to Loch Leven, encouraging use of local paths and developing more all ability trails.

There was a strong feeling that Kinross should make more of its local heritage – including making heritage information/interpretation/activities more accessible closer to Loch Leven and Kinross Town Centre.

Main priorities

- Loch Leven
- Retain and develop greenspaces
- Environment enhancement
- Develop and maintain paths networks
- Making more of local heritage

THEME 4: GETTING AROUND

Increase in housing has led to an increase in traffic within Kinross – and suggestions for ways of improving this – including road safety measures, alternative road and traffic flow systems, and offering alternatives for active travel.

People were keen to see that improvements took account of all abilities e.g. dropped kerbs, paths and pavements wide enough for wheelchairs and pushchairs.

Traffic reduction measures included the desire to see slip roads for Milnathort onto the M90 (Junction 7 M90 off ramp from and on ramp to the south), increased promotion and use of the by-pass, while road safety measures included slowing traffic down and having pedestrian crossings at dangerous crossroads.

Improved paths and cycle routes are needed within Kinross itself but also linking to other villages in Kinross-shire and Fife and beyond. The motorway is a major barrier to the creation of safe active travel routes between Kinross and neighbouring Kinross-shire villages and, in an ideal world, there would be a motorway underpass/overpass provided for walkers/cyclists. A safer route – other than through the town centre - was also proposed for connecting all the way from the bottom of Kinross to Milnathort.



While Kinross has good public transport connections there was still thought to be areas for improvement e.g. better services to the West (Stirling and Glasgow), better timetabling of buses to Perth, and local Kinross-shire/Fife services that helped connect villages to Kinross. Better access to rail services was also mentioned – ideally a new station! – but also better public transport linking to train services e.g. at Inverkeithing.

Main Priorities

- Road safety and traffic reduction
- Paths and cycle routes
- Pavement and paths for all abilities
- Public transport

THEME 5: COMMUNITY AND RECREATION

Kinross does not have a dedicated community or town hall but rather a number of 'shared use' buildings e.g. community campus, church halls, scout hall, rugby club pavilion, and hotels. This can mean that there is a need to 'make do' or overcome limitations which are sometimes cited as barriers to use. It also means that there is a need to enable people and groups to have a good overview of what is available. As a result a number of respondents would like to see more dedicated space for specific groups or for multi-purpose community use, e.g. a youth centre, arts centre, community centre.



In terms of recreational facilities

- Respondents were pleased to see that there are proposals and funding to upgrade the Leisure Centre
- It was noted that restrictions on use of existing outdoor sports pitches at the campus meant that there was a shortage of all-weather football pitches
- There was a desire to see ongoing improvements to local play areas



Main priorities

- Make the most of existing facilities
- Explore the need for new dedicated facilities
- Improve and develop sports facilities
- Improve play facilities
- Community groups working together and in partnership with others

THEME 6: ACCESS TO SERVICES

One of the overwhelming messages coming from the CAP consultation was that the growth in housing and population had not been met by a corresponding growth in services.

There was particular concern about the difficulties now faced in accessing health services and a desire to see this improved.



Over the years the work of local organisations including the Kinross Centre, Broke Not Broken, Kinross-shire Volunteer Drivers, The Men's Shed, She Shed, Kinross Trishaws and Community Cycling has grown along with the need for their services. It was recognised that their role in providing care and wellbeing services was vital and should continue to be supported and developed.



Local businesses and residents highlighted the need for better access to banking and post office services, with a request that at the very least there should be a Kinross Banking Hub and increased Post Office hours.

The CAP work also identified the need for more childcare – with a particular gap in holiday care for Primary School children identified – and with the need to ensure that existing services are supported and expanded.

Main priorities

- Health, Care and Wellbeing Services
- Banking and Post Office
- Childcare

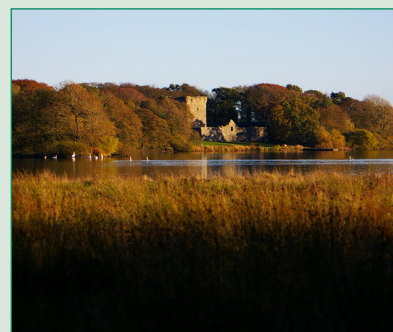

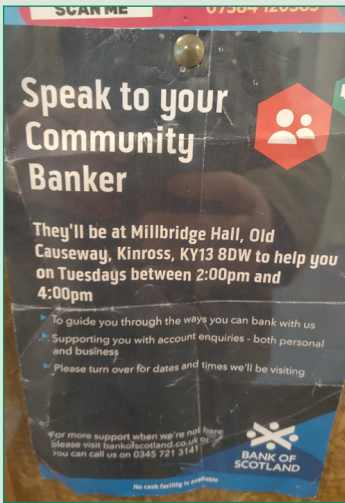

Kinross Community Council has an opportunity to use the relevant findings from this Community Action Plan to prepare maps of desired future land and building use (e.g. for green space, active travel, paths, employment, housing, flood mitigation, renewable energy etc.). This can be submitted as a Local Place Plan to provide community views to the Perth and Kinross Local Development Plan.

We will organise a Community Action Plan Annual Review event once a year to report back to the Community on how the plan is progressing and to see what progress is being made.
